That during the academic session, I shall try to attend all the lectures, clinics, tutorials, practical and other prescribed curricular & co-curricular activities so that my attendance shall remain 100%. I also understand that as per **NMC** rules, 75% attendance in each subject is compulsory to make me eligible to appear in College/University Examination. I also understand that Medical leave does not allow relaxation in attendance (as per **NMC** Guidelines).
3. That failing the attendance requirement, I shall not be permitted to appear in the college examination and University examination. I shall not lodge any complaint before any authority or court against any action taken by the college in this regard.
4. That I shall keep my parents informed regarding my monthly attendance and academic performance from time to time.
